## WHY CBD GLOBAL SCIENCES

- Debt restructuring activity over the past 18 months has reduced liabilities on the balance sheet by 75%.
- Modified our focus to industry consolidation activity with interest in profitable companies that need to consolidate into a public company to see scalable and sustainable growth.
- Creation of Legacy Distribution enables CBDGS to create a value proposition that is difficult for competitors to refuse. We help them achieve market penetration and brand awareness.
- Acquisition of the Resinosa established a road map on how to consolidate with a winning proposition for both companies. It also creates a revenue stream for The PUBCO as we assist companies to market by providing manufacturing opportunities as they scale their business.






# TIMELINE TO PUT WINS ON THE BOARD
